## After victory, battle continues

Faith-based child placement agencies face ongoing challenges


Sometimes in life, you have to take a stand.

This year, Southeastern Children's Home celebrates its 50th Anniversary. For 50 years, we've worked alongside the state of South Carolina to provide homes for children that have been abused or neglected. For 50 years, we have practiced The Great Commission by introducing young people to

Godly principles. For 50 years, we've tried our best to be the hands and feet of Jesus.

Yet, times are changing. Recently, the South Carolina Department of Social Services threatened to revoke a faith-based agency's child-placing license if it did not end its practice of only licensing Christian foster parents. This agency, Miracle Hill Ministries, has been a close ally and friend of ours for many years. After the state of South Carolina made this decision, our board of trustees voted to support Miracle Hill in its battle with the government's decision. Lines were drawn. We started to prepare for a huge argument and possible litigation.

Thankfully, in March, the disagreement was temporarily resolved when Governor McMaster signed an executive order which protects faith-based agencies such as ours. The governor's order states that the State has "no compelling interest in limiting faithbased organizations' participation as CPAs [Child Placement Agencies]."



While this is a victory for all faith-based organizations in our state, we aren't foolish enough to think this is the final battle. Unfortunately, faith-based agencies will likely continue to be scrutinized and subjected to ongoing disagreements.

Please continue to pray for our ministry as we seek to serve vulnerable young men and women in our state.

Also, please consider attending our 50th Anniversary Banquet on December 1st in Greer, SC. This is an event worth celebrating. Tickets can be purchased by visiting our website at sech.org. Come witness the lives that have been changed in our 50 years of service.

### J'len reunited with mother ahead of schedule

Reuniting a family is one of the best experiences here at Southeastern Children's Home.

We're happy to announce that J'len, one of our residents, was reunited with his mother this month.

J'len was originally removed from his home because of some deep-rooted issues with one particular family member. After being removed from his home, J'len's poor behavior and emotional issues led him to being placed at Southeastern Children's Home.

"Initially, J'len was incredibly defiant," SECH Case Manager Matt Howland said. "He never took responsibility for his actions. Everything was always someone else's fault, and he allegedly couldn't help who he was. He would have violent outbursts at the home and in school."

Over time, J'len began to adapt and make small changes.

"J'len was great with our 3-yr old son, Zander," House-Mom Rebecca Caroon said. "Some of our boys have a hard time coping with Zander, but J'len was like a big brother. We all miss J'len, but Zander is really going to miss him."

One of our goals at Southeastern Children's Home is to reunite children with their families when the time is appropriate. In J'len's case, his mother moved out of a dangerous situation and was able to complete her court-ordered treatment plan.




# an early homecoming
